Har-Bur Middle School Dance Policy - Grades 7 and 8

1. Parents should bring their children to a dance no earlier than 7:20 p.m. and pick them up ***promptly*** at 9:30 p.m.
2. Obvious displays of affection will not be permitted during a dance. After being warned, students who do not abide by the rules will be asked to call their parents and leave the dance.
3. Students who are found to be in possession or under the influence of any illegal substance (alcohol or drugs- including tobacco) may not be permitted to attend any other school activities for the remainder of the school year. They will be subject to discipline pursuant to administrative regulations and the school discipline policy, up to and including expulsion and referral for prosecution.
4. Students who are absent on the day of a dance ***may not attend*** the dance.
5. Anyone suspended from August 31, 2016 up to and including the day of the first dance ***may not attend*** this dance. Likewise, students suspended on any day between dances may not attend the subsequent dance.
6. Only Har-Bur students may attend a dance. ***Guests are not permitted.***
7. Students planning to attend any dance or all of the dances this year must return this notice to their homeroom teacher by Friday, October 14, 2016.
